Early Voting Proposal Summary

Submission Process

The Durham County Board of Elections is required to approve an Early Voting Implementation Plan for the 2020 General Election pursuant to N.C. Gen. Stat. 163-227.6(a). This is required since the Board has traditionally authorized alternative early voting locations to supplement the Durham County Board of Elections office or 'in lieu of' site.

If the implementation plan is unanimous among all members of the Board, it will be submitted to the State Board of Elections for review and approval. If the plan is not unanimous among all members of the Board, a majority and/or minority plan may be submitted to the State Board of Elections for consideration and potential adoption.

All proposed plans must be submitted to the State Board of Elections by July 31st for review and consideration.

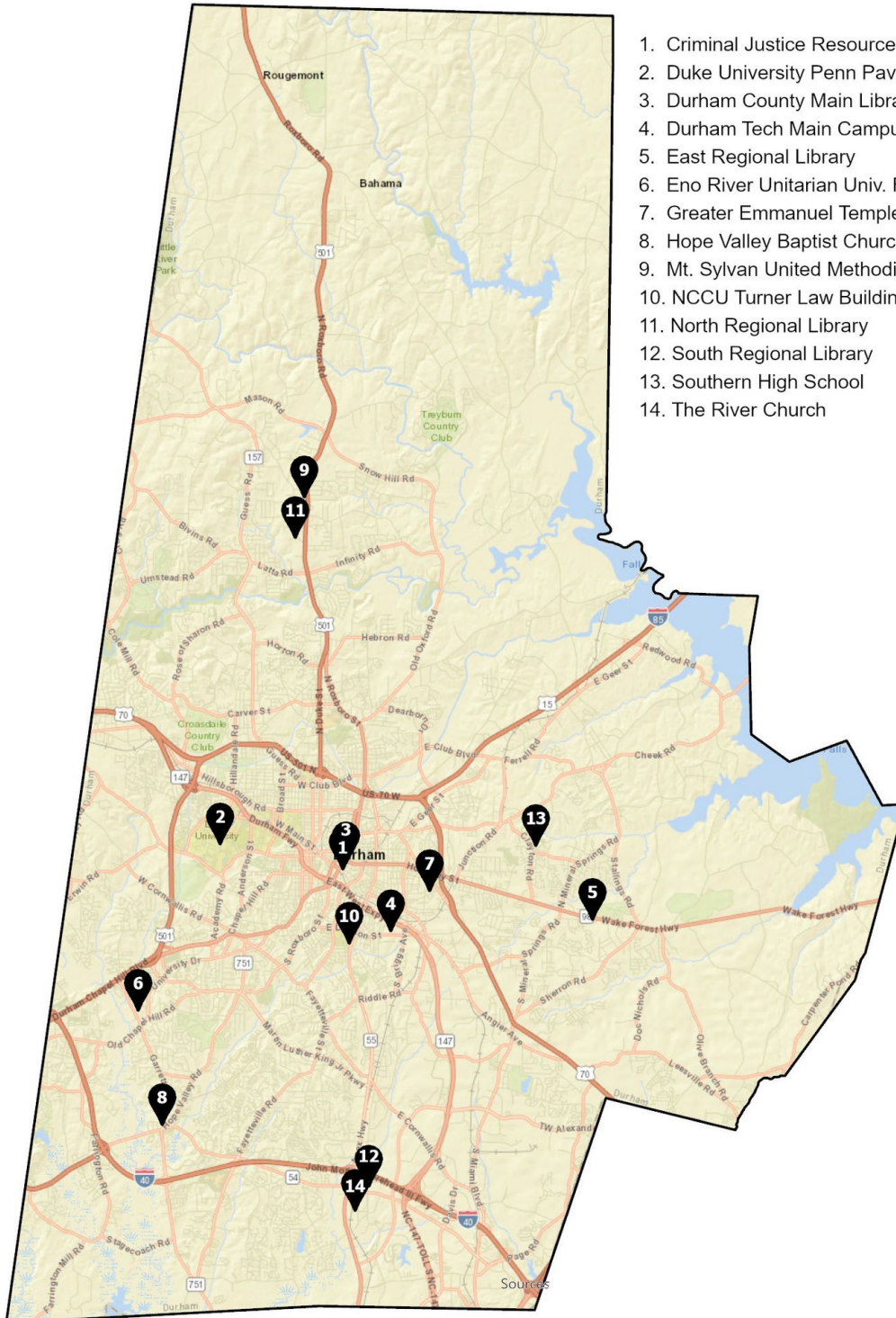
Proposed Plan

After careful review and consideration of interests required by statute, public comment, COVID-19 related restrictions and Board member consultation, staff of the Durham County Board of Elections propose a robust one-stop plan for the 2020 General Election. Highlights of the proposed plan are as follows:

- ✓ Establishes 14 locations throughout Durham County.
- ✓ Establishes 2,506 total hours of voting.
- ✓ Ensures Saturday and Sunday Voting at all locations.
- ✓ Ensures all locations are open uniformly for 17 days.
- ✓ Additional sites covered by CARES Act funding to remain within budget allocations.
- ✓ Implementation of additional large sites to support heavily utilized sites.



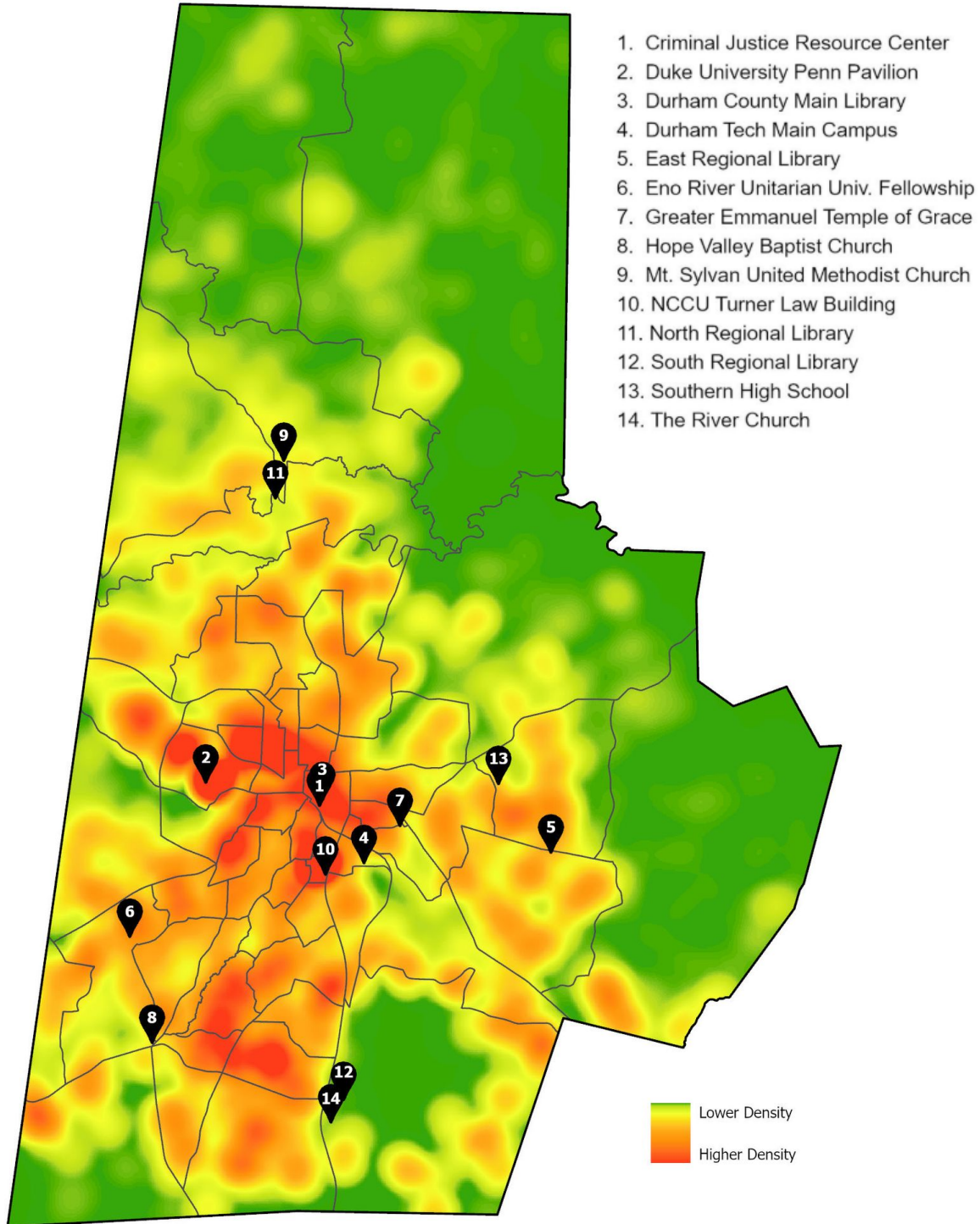

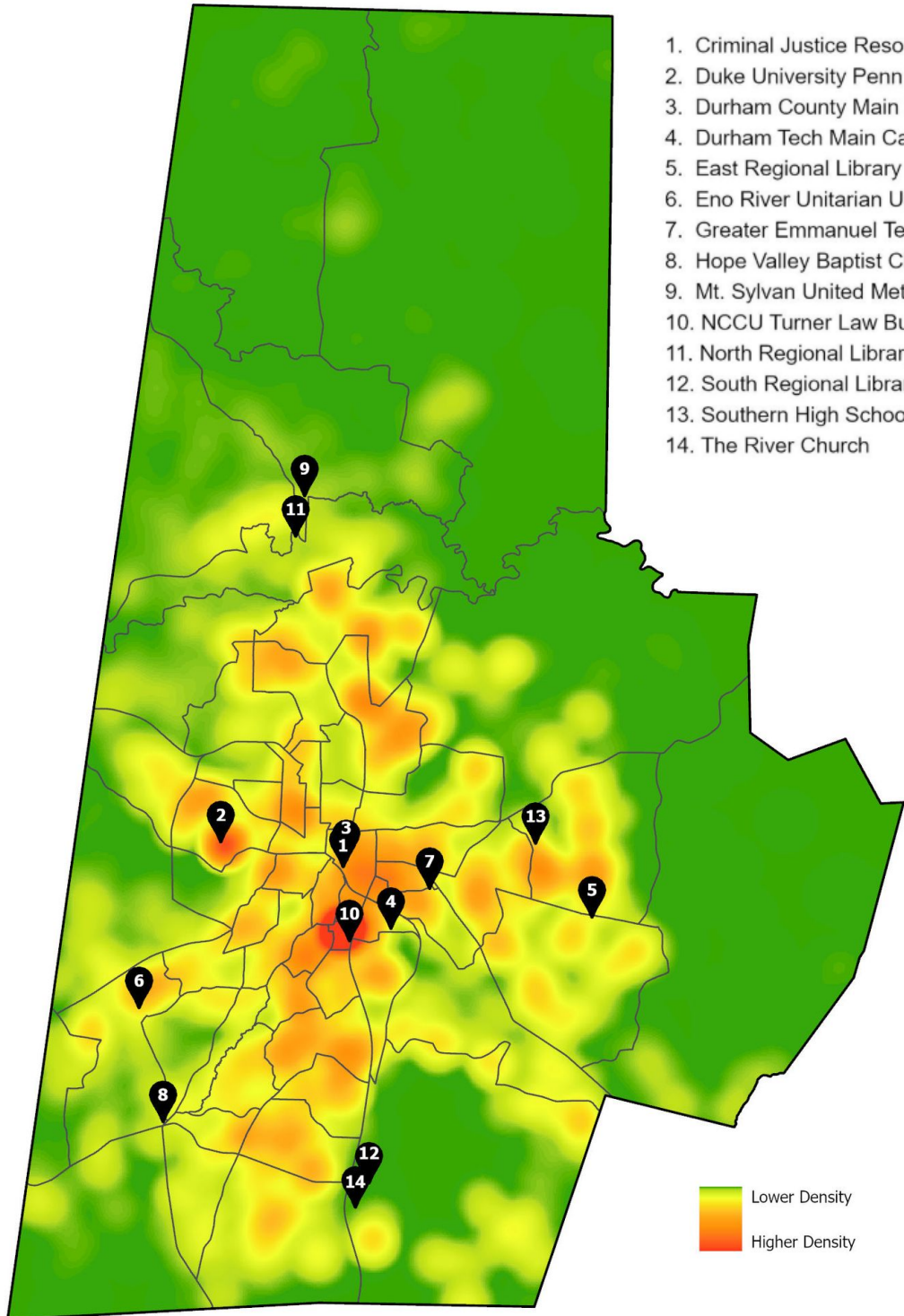


Density Map of Registered Voters in Durham County

Comparable Election Review

Hours Comparison

The total number of hours included in the 2020 Proposed General Election Early Voting Plan (2,506) establishes an approximately 62.6%% increase over the number of hours offered during the 2016 General Election Early Voting Period (1,541). This is attributable to expanded hours and an additional site.

Site Comparison

The total number of sites in the 2020 Proposed General Election Early Voting Plan (14) establishes an additional site when compared to available sites during the 2016 General Election Early Voting Period (13).

In assessing our strategy for acquiring proposed early voting sites for the 2020 General Election, we saw that 78% of early voters voted at five locations (In order of volume: South Regional Library, North Regional Library, Durham County Board of Elections Office, Eno River Unitarian Universalist Fellowship and East Regional Library) during the 2016 General Election Early Voting Period. There was a similar trend for the general election early voting periods in 2008 and 2012. To address this, staff has acquired large sites within close proximity to our historically busier sites to act as support/overflow locations.

Days Comparison

The total number of days offered in the 2020 Proposed General Election Early Voting Plan (17) is equal to the number of early voting days offered during the 2016 General Election Early Voting Period. Although voting was available each day during the 2016 General Election Early Voting Period, only 5 of the 13 voting sites were open during the first week of voting. The 2020 Proposed General Election Early Voting Plan ensures all sites are open uniformly for 17 days.

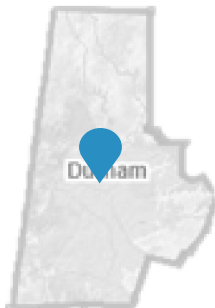
Durham County Main Library

Site Summary

The Durham County Main Library is located at 300 N. Roxboro Street, Durham, NC 27701. The Durham County Main Library will act as the 'in lieu of' site for the Durham County Board of Elections office. This site is centrally located in Durham County, ADA compliant, and is 0.1 miles from the Durham County Board of Elections office. The voting enclosure is the main conference room, which is approximately 1,849 sq. ft. Logistics related to security have been established for this site.

Site Facts

The Durham County Main Library will have 84 parking spaces allocated for voters and regular customers unless otherwise noted. The site will receive 10-15 voting booths and 4-5 electronic poll books. Social distancing requirements limit the amount of resources allocated to this location. The Criminal Justice Resource Center will act as a support site for this location.

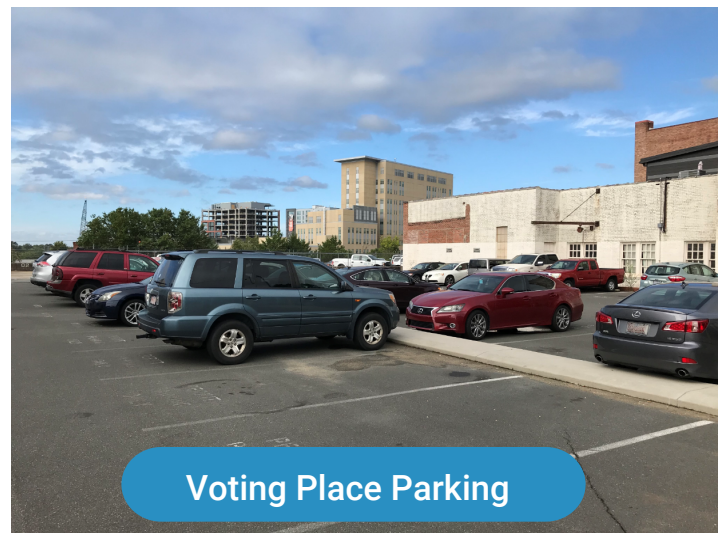
Site Summary

The Criminal Justice Resource Center (CJRC) is located at 326 E. Main Street, Durham, NC 27701. This site is centrally located in Durham County and is ADA compliant. The voting enclosure is the multi-purpose room, which is approximately 2,320 sq. ft. Logistics related to security have been established for this site.



Site Facts

The Criminal Justice Resource Center will have 47 parking spaces allocated for voters and regular customers unless otherwise noted. The spaces will be located in the main CJRC lot (32) and Social Services lot (15). The site will receive 15-20 voting booths and 4-6 electronic poll books.





South Regional Library

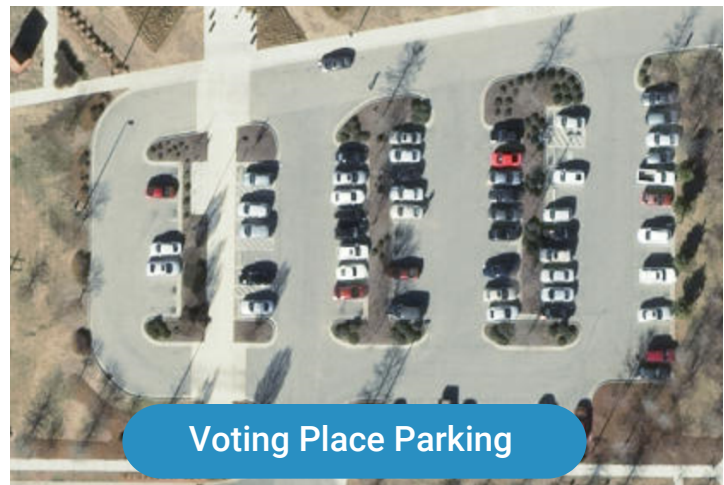

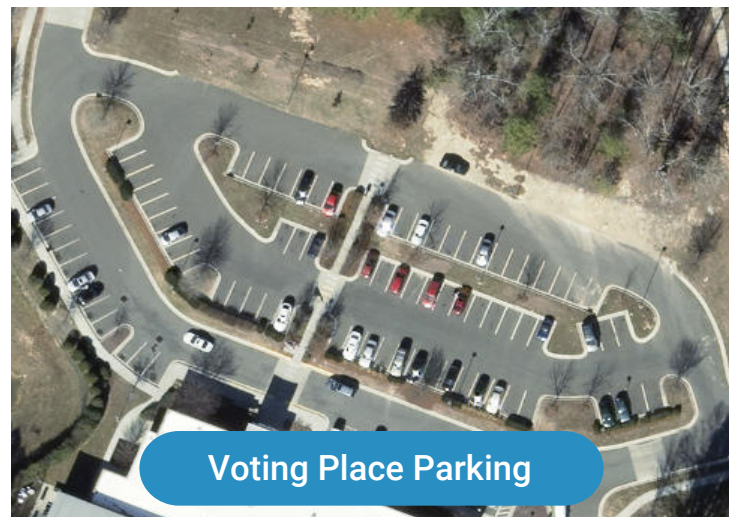

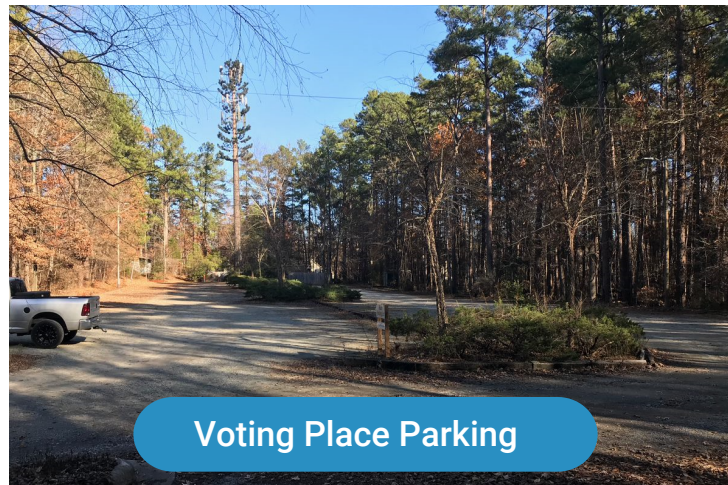
